RECOGNITION ORDER

Course of 2 Year with an annual intake of 50 (Fifty) seats from the academic session 2013-2014.
- Further, the institution is required to comply with all post-recognition conditions enumerated from Clause 8(11) to Clause 8(16) of NCTE (Recognition, Norms & Procedure) Regulations, 2009.
- The society sponsoring the institution shall transfer and vest the title of the land and building in the name of the institution within a period of six months from the date of this order and submit the documents to the Western Regional Committee. - The institution shall ensure that the required number of academic staff for conducting the course is always in position.
- The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its Official website.
